- WHEREAS, The County Board of Commissioners approved the annual Apportionment Report on October 13, 2020, and
- WHEREAS, on November 3, 2020 the voters in the Conway Township a 2.0000 millage road millage and
- WHEREAS, the electors of Brighton Schools approved a 2.2000 mill Non-Homestead additional millage, and
- WHEREAS, the additional millage will change the previous approved 17.9627 millage to 18.0000 mills, and
- **WHEREAS,** the Byron School District corrected the sinking fund millage from 2.9305 to 2.9061the request will be a .0244 decrease for the entire Byron School District.

Re:	Resolution – Correction to the Apportionment Report

Three corrections are needed to the apportionment report. On November 3<sup>rd</sup> the citizens of Conway Township voted in a new road millage of 2.0000 mills. The Brighton School District had a 2.2000 Non-Homestead millage approved this will increase the Non-Homestead millage from 17.9627 to the 18.0000 mills. This will offset any loss from the rollback it has seen in the past several years. Bryon Schools listed a 2.9305 millage for their sinking fund and it has been corrected to 2.9061 mills. This all is time sensitive due to the certification of the election and getting the tax bills printed.
