Chairwoman Nash spoke regarding the revised budget from Oceola Township and Conway Township's budget numbers.

R. Hanvey, representing the townships, stated that all budgets are in compliance and all are solvent.

Hilery DeHate, Senior Financial Analysts, expounded on the county budget. For the 2022 budget we estimate roughly \$52.5 million with a 1% increase in property taxes and a 3-year average on all other taxes. Expenses will see COLA and step increases along with a health care and pension estimate of a 4% increase and 3% increase in all other benefits. We are continuing to fund our Capital Improvement Plan Fund and plan to make a pension payment of approximately \$1.2 million. Budget is balanced.

Stephanie Weese, LESA, stated the taxable valuations of homestead and non-homestead property are projected at a 2.0% increase over FY 2021, state-aid payments in the General Fund are projected to increase by 2%, wages include a nominal increase and retirement rates will increase to 42%. She also noted there will be a balanced budget and LESA is requesting the .10 millage allocation again this year.
