

Proposed District Plan:

Dan Wholihan – Genoa Township.

What was difficult is getting a plan with low deviation due to large precincts. I was able to get this within 8.5%, under the 11.9% requirement and avoided triple splits. I wanted a plan that respected Communities of Interest due to the new Commission. I used Dave's Redistricting for the maps, but I used GIS when possible for the numbers and these numbers are accurate outside of possibly the small portion of Marion Township surrounded by Howell City.

District 1 – Most of Green Oak and City of Brighton – Population 22,280 – This district has most of Green Oak and most of the City of Brighton. I had to unfortunately split the city to keep Brighton Township and Genoa Townships whole. Green Oak Precinct 2 has very close ties to the City, and Green Oak 8 has close ties to Hamburg with Rickett Road.

District 2 – Most of Hamburg, Green Oak 8 (Rickett). – Population 20474 – I had to split Hamburg to keep the population under 23,000. This district is similar as before. It's a potentially competitive district and has all of the northern part of the Chain of Lakes and the Huron River corridor.

District 3 – All of Genoa Township. Population 20667 – Kept the same. There is a distinct Brighton side and Howell side to Genoa Township, but if Genoa does not get split, Marion and/or Brighton Twp and Howell City all do due to precinct sizes.

District 4 – Brighton Township and Precinct 1 in City of Brighton – Population 22280 – I didn't like splitting Brighton City, but I was able to keep Brighton Township whole by doing so.

District 5 – Hartland Township and Eastern Tyrone – Pop 20911- Hartland is made whole and eastern Tyrone near Fenton is added to the district (part of Hartland and Tyrone have Fenton addresses).

District 6 - Western Tyrone, Eastern Oceola, Deerfield, Cohoctah – pop 22036 – Deerfield is kept whole. The rest of the district has rural areas like Western Tyrone, Cohoctah (which did not want to be with Howell), and most of Oceola away from Howell City.

District 7 – Marion, Putnam, NW Hamburg – Pop 22327 (outside of portion of Marion surrounded by Howell) – Same as old district except all of Putnam is whole.

District 8 – Western portion – Pop 21816 - Same as old district except Howell twp 3 with closer ties to Fowlerville replaces Putnam 1.

District 9 – Howell City, Howell Twp near the City, Oceola near the City – pop 21888 (plus small part of Marion surrounded by Howell) – This is meant to create a Howell City based district. Cohoctah and Howell City aren't good fits, and SW Oceola is almost extension of the city. The neighborhoods near Howell City just north of Town Commons belong here.



Proposed Map and Description of Districts

I am pleased to submit 7 copies of a map I created using Dave's Redistricting, along with descriptions of each proposed district. Please consider it in your deliberations.

While there are no doubt maps (including some of which I created while getting familiar with Dave's) that score somewhat better on the compactness metric, this one has some features that I hope you'll agree are interesting -

- It recognizes the considerable growth of population in Tyrone Township since 2010.
- It keeps whole Hamburg Township, the County's largest, which today is represented by a non-resident.
- It puts the City of Brighton in a district with much of Genoa Township, with which it shares its longest border.
- It keeps whole not just Hamburg, but also Green Oak, as well as Handy, Iosco, Deerfield, and Marion (plus, of course, the townships that only have one precinct).
- It achieves an acceptable 10.37% population variance. 6.322
- It redresses the obvious gerrymandering that has resulted in multiple commissioners living very close to each other yet serving in different districts in the northeast and southeast parts of the County.

Here are my map's 9 districts -

- 1. Brighton Twp 1, 3, 4, & 6-9; and Hartland 3 & 5
- 2. Conway; Cohoctah; Deerfield 1 & 2; Howell Twp 1-3; and Tyrone 1
- 3. Tyrone 2-4; Hartland 1, 2, & 4; and Oceola 4
- 4. Handy; Iosco; Unadilla; and Putnam 1, 3, & 4
- 5. City of Howell; Oceola 1, 2, 3, & 5
- 6. Marion; Genoa 1, 2, 9, & 10; and Putnam 2
- 7. Genoa 3-8, 11, &13; Brighton Twp 2; and City of Brighton
- 8. Hamburg
- 9. Green Oak; Brighton Twp 5





Re: Proposed Livingston County Commission District Map

Attached are seven hard copies of a map created in the Dave's Redistricting app.

As a professional cartographer, my interest was to create a map that scored as highly as possible on three criteria, *ignoring everything else*:

- **Population variance 9.19**; lower is better. The min/max range in population is from 20,373 (5.42 percent below perfect equalization) in District 4, to 22,353 (3.77 percent above perfect equalization) in District 9.
- Number of township lines broken − 4; lower is better
- Compactness 100%; higher is better

As a citizen, I would want maps to be compared and rated *based solely on these or equally objective metrics*. Including other considerations seems to me to invite speculation that political, rather than demographic, factors are being used to draw maps.

Description of the map's nine districts, identified by city or township and precinct:

- District #1: Brighton Twp 1-4, 6, 7, & 9 + Hartland Twp 2 & 5
- District #2: Deerfield Twp 1 & 2 + Oceola Twp 1-5 + Howell Twp 2
- District #3: Tyrone Twp 1-4 + Hartland Twp 1, 3, & 4
- District #4: Conway + Cohoctah + Handy Precincts 1, 2, & 3 + Howell Twp 1 & 3
- District #5: City of Howell 1-3 + Marion Twp Precincts 1,2,3 &4
- District #6: Iosco Twp Precincts 1 & 2 + Unadilla Twp + Putnam Twp Precincts 1-4 + Hamburg Twp 3 & 6
- District #7: Genoa Twp Precincts 1-11 and 13
- District #8: City of Brighton + Hamburg Twp 1, 2, 4, 5, 7, & 8
- District #9: Green Oak Twp + Brighton Twp 5 & 8

Thank you for considering my map. With its perfect score on compactness, its small number of breaks in township lines, and its low population variance, I think you'll find that it will be hard for other maps to outperform it on objective criteria.



Description of Daubenmier Map 1 Submitted by Judy Daubenmier

This map meets all the criteria in the county reapportionment statute. It has a low population variance of 7.32 percent, a compactness score of 89, and five breaks.

The size of the districts ranges from 3.55 percent below the ideal in District 7 to 3.77 percent above in District 9.

On a rating scale from 0 to 300, this map scores 239. The breakdown is as follows: 89 points for compactness, 50 points for breaks, and 100 points for a population variance below 8 percent.

The districts are:

District 1: Brighton Township 1,2,3,4,6,7,9 and Hartland 2 and 5

District 2: Conway 1, Cohoctah 1, Deerfield 1 and 2, Howell Township 1, 2, 3 and Oceola 4.

District 3: Tyrone 1,2,3,4 and Hartland 1,3,4.

District 4: Handy 1,2,3, Iosco 1 and 2, Putnam 1,3,4, and Unadilla 1.

District 5: Howell City 1,2,3, and Oceola 1,2,3, and 5.

District 6: Marion 1,2,3,4, Putnam 2 and Genoa 1,2,5,9.

District 7: Brighton City 1,2,3,4, Genoa 3,4,6,7,8,10,11,13.







Description of Daubenmier Map 2

This map meets all the criteria in the county reapportionment statute. It has a population variance of 9.72 percent, a compactness score of 82, and four breaks.

The size of the districts ranges from 5.46 percent below the ideal in District 4 to 4.26 percent above in District 6.

On a rating scale from 0 to 300 (see below), this map scores 249. The breakdown is as follows: 82 points for compactness, 100 points for breaks, and 67 points for a population variance between 8.0 and 9.9 percent.




