#### 8. Director Reports

In September, LCVS Veteran Assistance Programs (VAP) provided a grand total of \$8,586.10 in relief funds. VAP relief funds were provided for Burial Benefits (\$4,600.00), rent/shelter assistance (\$1,920.00), VINA dental (\$1,135.00) and food assistance (\$931.10).

In September, LCVS Transportation provided 164 rides to medical appointments which is a value of \$2,628.36.

Director Baca provided an overview of the LCVS Quarterly Reports: Veteran Assistance Program (VAP), Fleet Summary and Fund reports and answered Committee questions.

Jason Gutierrez, VSO, Veteran Benefits Counselor II, provided a detailed summary of VAP appointments from Aug-Sept. 2024. There were 16 relief requests and 2 were potential VAP packets. In summary, VAP relief requests were either rejected because the veteran didn't qualify; were submitted to Michigan Veteran Affairs Agency Trust Fund, or other local partnerships were used to address the veterans' financial needs.

### Eligibility:

- 1. The veteran served at least 90 days of active duty unless discharged earlier due to a service-connected disability **AND**,
- 2. The veteran was discharged with "Honorable" conditions AND,
- 3. The nominee has been a Livingston County resident for at least 90 days.

For nominated veterans plus one guest of their choosing, a meal (brunch) will be provided at LCVS. LCVS staff will present nominees with a holiday card and \$100 gift card. For mobility challenged veterans, LCVS staff may join them on their shopping trip to assist.

LCVS to send invitations to nominated veterans by November 22 with RSVP's completed no later than December 9. This event is tentatively scheduled for December 13 from 9 a.m. to 11 a.m.
