VAP income limits in use are from 2023 and do not mirror current COLA increases provided by the VA. LCVS proposes to increase 2023 rates by six percent (6%) rounded up to the next full dollar (3% for 2024 and 3% for 2025).

8. Director Reports

Ramon Baca, Director, reported on LCVS office activity and financials. LCVS budget and outreach goals were discussed, and Committee questions were answered.

In November, LCVS Veteran Assistance Programs (VAP) provided a grand total of \$18,175.00 in relief funds. VAP relief funds were provided per Committee authorized VAP packet for heating cooling unit replacement (\$10,880.00), burial benefits (\$6,995.00), and food assistance (\$300.00). Also, LCVS Transportation provided 160 rides to medical appointments which is a fare value of \$1,579.00.

In December, LCVS Veteran Assistance Programs (VAP) provided a grand total of \$10,632.37 in relief funds. VAP relief funds were provided for burial benefits (\$10,346.00), and utility assistance (\$286.37). Also, LCVS Transportation provided 193 rides to medical appointments which is a fare value of \$1,611.00.

9. Committee Discussion

Kevin Nagle announced that there may be some legal assistance available for civil matters regarding eviction, divorce, custody matters. Ramon Baca, Director, will research and notify committee members, staff and Livingston County Veterans if assistance is available.

Joseph Riker discussed the new audit requirements for the Michigan property tax exemption for 100% permanently and totally disabled veterans. Director clarified LCVS instructions to veterans is to contact their local township or city assessor's office annually, due to assessors in Livingston County not applying legislation in the same manner. It has been recommended to State Legislators to require annual re-training to ensure that the law is applied consistently throughout the county and the state. The lack of common application seems to be an on-going issue which often leaves veterans and/or widows confused and frustrated. LCVS continues to work with township and city assessors to ensure both our clients are satisfied.
