Review of quotes for annual Memorial Day flag purchase. With inventory on hand and current need, LCVS requests to purchase 3,888 flags for Memorial Day distribution across Livingston County.

Recommended motion: Motion to approve purchase with Collins Flags in the amount of \$6,083.10 with a 10% contingency.

7.2 Memorial Flag Boxes

Review quotes for flag boxes. LCVS requests the purchase of 146 flag boxes for distribution to veteran families qualified for Livingston County burial benefits, for the timeframe of 1 Oct. 2024 to 30 Sept. 2025. Once authorized, the CVSF FY25 Amendment 1 will provide reimbursement for \$6,542.51 of this purchase.

Recommended motion: Motion to approve purchase of 146 flag boxes from Medals of America in the amount of \$6,542.70 with a 10% contingency.

8. Director Reports

In February, LCVS Veteran Assistance Programs (VAP) approved thirteen (13) applications and provided a grand total of \$12,033.58 in relief funds. Ten (10) VAP applications provided burial benefits for a total \$9,795. One (1) VAP application provided rental assistance for \$1,500 and two (2) VAP applications provided food vouchers for a total of \$738.58. In total this year, LCVS has approved twenty-two (22) VAP applications and provided \$20,361.54 in relief

8. Director Reports

Ramon Baca, Director, reported on LCVS office activity, transportation and financials.

In January, LCVS Veteran Assistance Programs (VAP) approved nine (9) applications to provide a grand total of \$8,327.96 in relief funds. Five (5) VAP applications provided burial benefits for a total \$5,000. Two (2) VAP applications provided rent assistance (\$1,500) and emergent shelter assistance (\$900) for a total of \$2,400. One (1) VAP application provided utility assistance (\$745.15) and one (1) VAP application provided a food voucher (\$182.81).

LCVS Transportation provided 183 rides to medical appointments which is a total fare value of \$1,598.00.

LCVS was notified the Michigan Veterans Affairs Agency (MVAA) County Veteran Service Fund (CVSF) FY25 grant was reduced from \$140,436 to \$79,854. This is a reduction of \$60,582 which impacts the Administrative Specialist position salary.
