The Livingston County Parks & Open Space Advisory Committee is seeking support for designating the Lutz County Park as a Michigan Dark Sky Preserve. Part 751 of the Natural Resources and Environmental Protection Act (Act 451 of 1994) allows for the designation of state-owned lands and other lands as approved by the Michigan Legislature to be designated as dark sky preserves.

- WHEREAS,** Livingston County’s current contract with Axon Enterprise, Inc is nearing expiration; and
- WHEREAS,** the Jail has been under contract for tasers, taser cartridges and training with additions over the contract term for additional hardware and software which has resulted in varying payment and upgrade schedules; and
- WHEREAS,** the current contract for tasers expired on 12/31/2024 with varying expirations for additional hardware software added during contract term; and
- WHEREAS,** Axon has provided a quote for a (5) year agreement for all services, hardware and software; and
- WHEREAS,** included in this quote are (17) Taser 10’s (upgraded from Taser 7’s), (4) BWC (Body Worn Cameras – 2 of 4 are additional to current), (2) Fleet 3 In-Car Cameras (additional); and
- WHEREAS,** the use of tasers by all transport and some jail deputies have maintained safety and security, minimizing the risk of injuries to both inmates and staff; and
- WHEREAS,** the use of Body Worn Cameras for hospital guard and high risk inmate transports in correlation with the Fleet 3 in-car cameras will be additional measures that will enhance the safety and security of inmates and staff, as well as serve as liability protection for the County; and
- WHEREAS,** the (5) year agreement Grand Total is \$434,030.26 at the following annual breakdown; and

Re: Resolution Authorizing Livingston County Jail to Enter into a bundle contract for Tasers, Body Cameras, and Jail Fleet Camera Services

As we approach the end of our current contract with Axon Enterprise Inc., we have revisited the services they provide to the Livingston County Sheriff's Office. Over the past decade, the Livingston County Jail has been under contract with Axon to provide tasers, cartridges, and training. Over the years, additional hardware and software items have been added, resulting in the jail and Axon serving different payment and upgrade schedules and requirements.

We are seeking to acquire 17 updated Tasers (Model T-10) that will enable all our transport deputies, as well as some of our jail deputies, to carry them while on duty. Tasers have, through our experience, allowed our staff to maintain safety and security during jail operations, minimizing the risk of injuries to both inmates and staff.

We also seek the addition of two body cameras for the hospital guard and high-risk inmate transports, as well as two in-car fleet cameras for our federal transport vans. We are confident that these additional measures will significantly enhance the safety and security of our staff and inmates and result in liability protection for the county.

We respectfully request the board's approval for the Livingston County Jail to enter into a five-year agreement with Axon Enterprise, Inc. This agreement is crucial to the safe operation of our facility and will protect both staff and inmates. The authorization of this Resolution will ensure a smooth transition to improved and uninterrupted service from the provider.

The Livingston County Community Corrections Advisory Board (LCCCAB) approved submission of the Community Corrections Plan and Application for FY 2025 on April 25th, 2025.

The Community Corrections Plan and Application is requesting \$124,475.49 in funding for the comprehensive plan and services listed:

- **Cognitive Behavioral Treatment Programming**
- **Substance Use Disorder Treatment Assessments and Programming**
- **Administration**
- **Supplies**
- **Training**

All programming under Community Corrections is evidence based and designed to reduce Prison Commitment Rates (PCR) as well as recidivism rates. Cognitive Behavioral programming is designed to promote skills to develop prosocial behavior and impact potential future criminal behavior by teaching how to identify, monitor, and change the thinking that is fundamental to these behaviors. Substance Use Programming is designed to help offenders understand, recognize, and accept addiction; identify and interrupt addictive thoughts, feelings and actions; and learn positive, healthy coping skills that negate the need for prison commitment. Lastly, the Program Director and Coordinator are responsible for the development, implementation, and monitoring of the Community Corrections Plan. These positions act as an advisor to the CCAB and liaison to the state. These positions also monitor program utilization and progress toward meeting objectives.

Through this grant, the LCCCAB is committed to reducing the prison commitment rate by providing alternatives to incarceration and services to reduce recidivism.

This grant is not requesting funds for any new positions and does not require a match.
