## Resolution Authorizing Specialty Courts and Programs to Accept the State Court Administrative Office Grant Awards for FY 2022 – Court Central Services

- **WHEREAS,** Livingston County's 53<sup>rd</sup> District Court and the 44<sup>th</sup> Circuit Court constitutes a jurisdiction designated to operate Specialty Courts and Programs; and
- WHEREAS, Specialty Courts and Programs are seeking approval to accept the awards received for FY 2022 Michigan Drug Court Grant Program (MDCGP) funding for Juvenile Drug Treatment Court and Adult Drug Court; and
- WHEREAS, Specialty Courts and Programs are seeking approval to accept the award for Swift & Sure Sanctions Probation Program (SSSPP) funding for FY 2022; and
- WHEREAS, Specialty Courts and Programs are seeking approval to accept the award for FY 2022 Mental Health Court Grant Program (MHCGP) funding for Intensive Treatment Mental Health Court; and
- **WHEREAS,** Specialty Courts and Programs are seeking approval to accept the award for Michigan Veterans Treatment Court Grant Program (MVTCGP) funding for FY 2022; and
- WHEREAS, The 53<sup>rd</sup> District Court and 44<sup>th</sup> Circuit Court will use these funds for current staffing, treatment, drug and alcohol testing, training, and other program-related expenses necessary to operate the Livingston County Specialty Courts and Program during FY 2022.

**THEREFORE, BE IT RESOLVED** the Livingston County Board of Commissioners authorizes Specialty Courts and Programs to accept the SCAO FY 2022 funding awards for five (5) Specialty Courts and Programs in the award amounts below:
