Dear Livingston County Board of Commissioners,


It has come to my attention that my LCCMHA Board appointment will expire on 12/31/2022. I continue to have interest in extending my appointment for another term.

I have been part of the Brighton community for the past four years, after raising my family in Plymouth/Canton. I have a PhD in Theoretical Evaluation and Research with a Minor in Community Medicine from Wayne State University. I believe my educational background allows me to bring a unique perspective to the Board, one firmly grounded in research methods and statistics and a deep understanding of the literature that underlies best clinical practices.

I currently work at the University of Michigan Medical School (UMMS) as the Director of Evaluation, Assessment, and Quality Improvement.
