Resolution Authorizing the Reclassification of Veterans Benefits Counselor Positions – Veteran Services

- **WHEREAS,** the Veterans Services Office has three levels of Veterans Benefits Counselor positions, which are commensurate with education and experience in the role; and
- WHEREAS, the Veterans Services Office and Committee wishes to convert two current Veterans Benefits Counselor I positions to Veterans Benefits Counselor II positions, based on both counselors having obtained the level of experience required to move up; and
- WHEREAS, the Veterans Services Office and Committee supports reclassifying the current Veteran Benefits Counselor-Relief and Veteran Benefits Counselor-Claims positions into one classification, Veteran Benefits Counselor that is cross-trained in both Relief fund and Claims duties; and
- **WHEREAS,** the positions have been evaluated by MGT Consulting Services, L.L.C., who is recommending combining of Veterans Benefits Counselor -Relief and Veteran Benefits Counselor-Claims into a single three-tiered classification based on education and experience.
- **THEREFORE BE IT RESOLVED** that the Livingston County Board of Commissioners hereby authorizes the conversion of budgeted Veterans Benefits Counselor I positions to Veterans Benefits Counselor II positions and authorize any budgeted amendments necessary to effectuate the above change, effective January 1, 2023.
- **BE IT FURTHER RESOLVED** that Veterans Benefits Counselor Relief and Veteran Benefits Counselor-Claims be reclassified into a single three-tiered classification based on education and experience.
