This program is designed to provide funding for sustainable projects that promotes optimal health for those populations who are poor and vulnerable based on the Irinity Health Ann Arbor & Livingston 2021 Community Health Needs Assessment (CHNA) and CHNA Implementation Plan. A goal for the Community Paramedic program by design is to provide alternatives to traditional treatment and transport of EMS patients as well as to reduce the amount of 30 day readmission rates of referred patients. The program typically focuses on medically and socially underserved populations that are at higher risk of using the emergency department. A Community Paramedic can reduce the burden on other providers, reduce unnecessary transports and readmission to the ER, increase access to primary care and improve quality of life. This will apply to patients referred to the Community Paramedic program through the Trinity Health System, local physician groups as well as the field paramedics of Livingston County. The objective of the grant is to obtain a Piccolo Express and a portable ultrasound. These will allow our Community Paramedic to acquire blood work, identify acute issues and trend chronic conditions. We are seeking the funding in the amount of \$24,000 to purchase this equipment and integrate it into our system.

In the past we have used the I-Stat machine. Since then the I-Stat is no longer CLIA waived for this program and we will be moving to the Piccolo express for our diagnostic capabilities. This will allow us to do blood work in the patient's home and be able to report back to the primary physician that had ordered it. We are also including a portable ultrasound in this grant application to be able to further our scope of diagnosis and treatment of patients within their home. This grant will allow us to buy the Piccolo express, cartridges, ultrasound and the software needed.




