Resolution to Authorize an Agreement for the Delivery of Comprehensive Health Services Grant for the Period of October 1, 2023 through September 30, 2024 – Health Department

WHEREAS, The Livingston County Health Department has determined a need for provision of the delivery of comprehensive health services; and

WHEREAS, These services are basic, required, and allowable health services under Act 368 Public Acts of 1978, and individual categorical contractual services; and

WHEREAS, The Michigan Department of Health and Human Services will provide a contractual relationship to partially reimburse Livingston County for the following health services (estimated amounts listed below),

WHEREAS, the Michigan Department of Health and Human Services will provide a fixed fee reimbursement for services completed under the Body Art, CSHCS Care Coordination, Immunizations, and Lead Case Management programs; and

WHEREAS, the Michigan Department of Health and Human Services may propose future amendments for the purpose of revising the funding or terms of the agreement; and

WHEREAS, this funding has been awarded annually from MDHHS and is a vital part of all local health department funding in Michigan.

THEREFORE BE IT RESOLVED that the Livingston County Board of Commissioners hereby authorize an Agreement with the Michigan Department of Health and Human Services for the delivery of comprehensive health services in Livingston County during the period of October 1, 2023 through September 30, 2024 in the amount of \$1,645,963, upon review by Civil Counsel.

BE IT FURTHER RESOLVED that the Livingston County Board of Commissioners hereby authorize the Health Officer to electronically sign this agreement, and any future amendments for monetary and contract language adjustments of the above-referenced Agreement upon review and approval by Civil Counsel.

BE IT FURTHER RESOLVED that any deletions or additions of programs shall require Board approval.

BE IT FURTHER RESOLVED that the Board of Commissioners authorizes any budget amendment to effectuate the above.
