1.2 Qualifications

- A. The proposer must have global brand name recognition.
 - Avfuel is consistently recognized by notable industry organizations for its leadership and expertise in fuel, sustainability, safety, education, industry practices and brand marketing. Avfuel's executive team members and managers serve in leadership positions with numerous industry organizations to advocate for business aviation and further innovation. Recently, Avfuel's president and CEO, Craig Sincock, was inducted into the Living Legends of Aviation, honored with a Lifetime Aviation Entrepreneur Award and awarded NATA's highest honor: The William A. "Bill" Ong Memorial Award. Avfuel's manager of alternative fuels, Keith Sawyer, was also recently recognized by Corporate Jet Investor as a Sustainability Power Player.
- B. Proposer must be a long-term aviation refiner and/or marketer with a minimum of ten (10) years of experience in aviation turbine and aviation gasoline fuels.
 - Earlier this year, Avfuel celebrated its 50th anniversary. In those 50 years Avfuel has become an expert in sourcing, transporting, and delivering product around the globe and is involved at every level of the fuel delivery process –from refinery to wingtip. Avfuel has agreements with more than 100 refiners and 350 supply terminals globally.
- C. Proposer should include a narrative of the company's performance record with clients (airports where you provide similar service). Proposer must include a minimum of three (3) references complete with phone numbers (see Section 2.2 References).
 - Avfuel has been in a perpetual growth mode since its inception, and that is due primarily to our ability to provide stellar service and value to our branded dealer network. Providing value through card processing, staff training, truck leasing, reliable supply, competitive pricing, and always searching for new ways to drive business to and increase the efficiencies of our branded dealers are our keys to success. Please see Section 2.2 for specific examples.
- D. Proposer must confirm that they will provide weekly fuel price notices to the County.
 - Avfuel can provide weekly fuel price notices for Jet A and Aviation Gasoline via email, secure access to Avfuel's website, or both. Such notice can be provided for any personnel the County deems worthy.

1.3 Product Requirements

A. Fuel Requirements

As an indicator of Fuel Farm requirements, the following represents the estimated number of gallons required:

Jet A*	250,000

AVGAS 100LL	70,000

^{*} It is anticipated that that this volume will increase during the term of the agreement.

Supplier must be able to handle these approximate amounts and any increases in demand generated by special events affecting the sale of aviation fuel at the Livingston County Spencer J. Hardy Airport.

Particularly in Michigan, where Avfuel has a very large amount of contracted business and multiple sources of both Aviation Gasoline and Jet A, we can support the Airport's projected annual volume and any increases to that volume that may occur throughout the contract term. To prove this point, the Airport has exceeded its estimated annual Jet A requirement of 250,000 gallons each of the past three calendar years and Avfuel has been able to supply that increased demand without issue.

B. Fuel Specifications

- 1. <u>Jet A</u> Shall meet the requirements of American Society for Testing and Materials (ASTM) D-1655 (latest revision).
- 2. Avgas 100LL Shall meet the requirements of ASTM D-910 (latest revision).
- 3. Livingston County will perform and document the following tests before shipments are unloaded at the Fuel Farm:
 - a) Visual
 - b) Color
 - c) Bottom sediment and water
 - d) Temperature
 - e) API Gravity

Livingston County may perform additional tests and reserves the right to reject any delivery it deems unsuitable. Livingston County maintains the right to reject any operator/truck violating rules of safety.

All aviation fuel products delivered by Avfuel will conform to the specifications listed above (or whatever specifications for aviation fuel may be applicable at the time). Avfuel's transport truck drivers expect the above tests to be performed before offloading and may be available to assist County personnel in conducting such tests, if desired.

1.4 Service Requirements

1.4.1 Quality Control Program

- i. Updated Quality Control Manuals which are current and were revised within the last five (5) years.
- ii. On-site training (via contractors and/or salaried employees).
- iii. Fuel Farm inspections and documentation.
- iv. Refueler inspections and documentation for leased and/or County-owned refueler(s).
- Avfuel's Quality Assurance Department has developed a comprehensive fuel-handling, safety-training program. We provide Avfuel-branded FBOs and airports with ongoing consultation, education, training materials, testing and seminars, in addition to 24/7/365

- support for emergencies related to breakdowns, fuel spills, aircraft accidents or fuel quality problems.
- Specifically for the Livingston County Airport, this means free access to the Avfuel Training System in addition to on-site inspections and training upon request, including support for any airport operated refueler truck (whether owned or leased).
- Avfuel's Quality Assurance and Technical Assistance team is made up of Avfuelemployed experts (not subcontractors) who collectively have nearly 200 years of experience in aviation fuel handling, testing, distribution and equipment repair.
- Those same experts conduct Avfuel's Part 139 Supervisory Fuel Safety Training Seminars, of which Livingston County Airport has been regular participants.

1.4.2 Quality Control and Assurance Guarantees

- i. Meet ASTM specifications stated in contract not by an amendment to contract.
 - (a) Avgas 100LL ASTM D-910 (latest revision).
 - (b) Jet A ASTM D-1655 (latest revision).
 - Noted, ASTM specifications will be met by Avfuel for all deliveries to Airport. Aviation fuel Supply Agreement's Terms and Conditions include language requiring such.
- ii. Ability to trace fuel product shipments from refinery to Livingston County Spencer J. Hardy Airport's fuel farm.
 - All shipments will be traceable to the refinery for both Jet A and Aviation Gasoline.
- iii. Handling and disposition of "off-spec" products.
 - If any questions arise as to whether product delivered by Avfuel does not meet specification, Avfuel's Quality Assurance dept. will assist Airport personnel in further testing. If product is deemed off-spec, Avfuel will handle removal and disposition of product and coordinate delivery of onspec fuel.
- iv. Transportation of product via supplier approved fuel carriers.
 - Historically, about 95% of fuel deliveries to the Livingston County Airport have been executed by Avfuel-employed drivers using Avfuel-owned transport trucks. When common carriers are used for deliveries, they are audited to ensure compliance with Avfuel's loading guidelines.
- v. Supplier/transporter will provide documentation detailing what was previously contained in the delivery vehicle and method of cleaning, if appropriate.
 - All fuel deliveries will be accompanied by Avfuel's Product Receipt Certificate (PRC), which is a document completed by the driver showing what was previously hauled in the trailer and provided by the driver.
- vi. Documentation of pre-delivery testing.

- Any pre-delivery testing will be shown on Certificate of Analysis (COA) and PRC, as provided by the driver.
- vii. Supplier to provide inspection service at no additional cost.
 - Acknowledged
- viii. State frequency of inspections and items to be inspected:
 - (a) Fuel Farm
 - (b) Refuelers regardless of ownership
 - Avfuel will provide on-site inspections of Airport fuel and refueler trucks annually by request.
- ix. Provide written documentation of inspections.
 - Written documentation will be provided to airport manager.
- x. Provide contractor and/or salaried personnel for repairs on refuelers.
 - Avfuel will provide salaried personnel for phone support and technical assistance.
- xi. Description of Quality Control manuals and currency.
 - Quality Control Manuals are site-specific documents relating to a specific airport or FBO's own individual refueler trucks, fuel farm, and specific operational requirements. Through the Avfuel Training System, Avfuel offers dealers a state-of-the-art training system that is continually updated to meet the changing industry standards of ATA 103, NFPA 30, NFPA 407 and related standards.
- xii. Description of on-site Training Programs.
 - Avfuel will perform on-site training and inspections annually by request. Sessions usually last one day and include full inspections on all Airport-operated refueler trucks (owned and leased), fuel farm, record keeping and fuel quality testing procedures. The visit is part audit and part education but leads toward improving the Airports operation.

1.4.3 Professional Line Service Training Program

- i. Description of training programs offered.
- ii. Training must include the following areas: ground servicing, safety, refueling piston aircraft, refueling turbo prop aircraft, refueling jet aircraft, towing, fuel farm management, customer service, and fire safety.
- iii. Date of training revision. Program must be current and revised within the last five (5) years.

⋈ (i. – iii) Please see Attachment B for a description of the Avfuel Training System (ATS). It is web-based, updated continually to meet current industry standards, and includes all the components specified above and many more. Plus, we are providing it for free – a savings of \$3,200 over the life of the contract term.

1.4.4 Refueler (Vehicle) Lease/Purchase Programs

Please note: Livingston County owns a 3,000-gallon and a 2,200-gallon Jet A refueler.

- i. Description of refuelers available through supplier.
 - Avfuel has over 800 refueler trucks in our leased fleet. We build, refurbish and re-chassis those refueler trucks in our dedicated truck shop in Ann Arbor. Whether the Airport wants brand new or older models, large or small, Avfuel has a wide enough selection to meet any need.
- ii. Lease costs, model year and sizes of truck availability Jet A.
 - Avfuel would like to offer the Livingston County Airport the lease of a fully-refurbished 2007 International 3,000-gallon Jet-A refueler truck. This truck will have undergone a full-refurbishment in Avfuel's Ann Arbor refueler truck facility with improvements to include, among other upgrades, a new engine, new wiring, electronic meters and configuration for a Scully system. This truck has a standard lease rate of \$1,650.00 per month, but Avfuel is pleased to offer it to the Airport at a discounted rate of \$1,170.00 per month. As an alternative to a monthly lease payment, Avfuel will give the Airport the option to lease the truck for \$1.00 per month with an additional \$0.0475 per-gallon premium added to the Airport's weekly Jet fuel price. Please reference Attachment C for additional information.
- iii. Lease costs, model year and sizes of truck availability Avgas.
 - Avfuel is pleased to offer Livingston County Airport the continued lease of Avfuel Truck #731 (2005 Isuzu, 750-gallon, VIN JALB4B16557008846) at the lease rate of \$1.00 per month for the duration of the contract term. Should this particular truck need to be replaced, Avfuel will do so with a similar sized and vintage truck at the same lease rate of \$1.00 per month.
- iv. Maintenance provided on refuelers as part of lease agreement, if any.
 - Generally, most routine maintenance is the responsibility of the lessee.

 Avfuel will cover replacement or overhaul of the engine, transmission, belly valve and differential.
 - As an added value for the Livingston County Airport, Avfuel would like to offer \$2,000.00 per year (\$10,000.00 total for the duration of the contract) to be used for the reimbursement of maintenance expenses incurred by the County for any leased or owned refueler trucks. This amount is in addition to any maintenance expenses that are already the contractual responsibility of Avfuel.

- v. Flexibility to change refueler size.
 - Avfuel's refueler lease agreements are purposely flexible. The terms are month-to-month, allowing for termination of a lease at any time or the ability to upgrade to a newer, older, larger or smaller truck.
- vi. Availability of back-up refuelers to meet special needs or temporarily replace refuelers out of service for mechanical repair.
 - As has been previously demonstrated for the Livingston County Airport, Avfuel has a large fleet of refueler trucks that can be deployed quicky for special events or emergency situations. Most of our trucks are based less than an hour's drive away.

1.4.5 Credit Card Processing Program

A nationally recognized online credit card program that utilizes PC based or Point of Sale (POS) equipment. The PC based or POS system should consist of no more than one terminal and associated printer. The POS system must meet credit card industry processing standards and be capable of electronically processing credit cards with monies returned to Livingston County Spencer J Hardy Airport electronically within 48 hours. The system should process the following internationally recognized supplier retail credit cards: MasterCard, Visa, Avcard, American Express, Multi Service Card, Discover, U.S. Government Air Card and Voyager.

i. List credit cards accepted by supplier.

- Supplier must currently accept Avcard and Multi Service through a common PC based or POS equipment and printer that is utilized to process all supplier accepted credit cards.
 - Avfuel accepts Avcard and Multiservice through POS system.
- iii. Identify processing fees associated with each credit card accepted.

- iv. Identify credit card reimbursement timing and method of transferring funds to Livingston County Spencer J. Hardy Airport. Identify charge back procedures and timing.
 - Credit card funds are reimbursed twice per week (Tuesday and Friday within 2-4 days of processing and can be applied against fuel purchases or deposited electronically into a bank account of the County's choosing.
- v. Identify any technology enhancements or developments in process that may be available in the future.

- Avfuel is constantly working to improve our POS system and increase our offerings. Livingston County will be made aware if new offering become available through Avfuel.
- vi. List the available reports provided by the POS system. Reports should, at a minimum, provide daily detail and receipts showing fuel prices, discounts, et al., (i.e., retail price less discount net price).
 - POS system can show daily batches, fuel pricing, and discounts. In addition, it allows you to create custom profiles for regular customers and tenants.

1.4.6 National Advertising

- i. Provide national advertising that supports the fuel brand.
 - Avfuel customers benefit from the marketing power of a recognized and trusted global brand. As a member of our network, our marketing team works for you, providing creative strategies customized to meet your specific needs. Avfuel marketing combines proven communication platforms with innovative technologies to help you attract business, earn customer loyalty and increase sales. Additionally, Avfuel provides a number of training and support solutions to facilitate the implementation of our marketing efforts and support our commitment to your FBO. The Avfuel Marketing System taps into the power of the entire Avfuel Network, giving your individual FBO the reach of a widely-recognized global brand and putting you squarely in front of Avfuel's wide variety of aviation customers. Avfuel advertises regularly in several national industry publications and promotes our brand by attending aviation trade shows in virtually every state and around the world.

1.4.7 Co-operative Advertising Program

- Provide a flexible co-operative advertising program for promotion of fuel sales and Livingston County Spencer J. Hardy Airport services. Supplier must provide details of how credit is applied and maintained.
- ii. Participate in special project(s) or local advertising costs.
- iii. Aviation directory support by supplier.
- iv. Sales aid items provided through supplier and cost thereof.
- v. Explain how sales credits are accumulated and maintained for co-op programs.

1.4.8 Convention Brand Representation

- i. Provide brand representation at the NATA and NBAA conventions.
- ii. Identify trade show participation by supplier.
 - (i.- ii.) Avfuel is extremely active at all national aviation trade shows, particularly the NBAA-BACE, Schedulers & Dispatchers, NBAA Regional Conventions, plus many others. We have been the trend setters among fuel suppliers in terms of how to effectively create positive energy around a brand and how to use the trade shows to bring tangible business to our branded dealer network.

1.4.9 Line of Credit

- i. Provide adequate line of credit with functional credit terms with or without discount. Livingston County requires thirty (30) days to process fuel invoices.
 - Avfuel has and will continue to provide the County will 30 days terms and an adequate credit line.

1.4.10 Brand Identification

- i. Provide details of how supplier will provide and install brand identification.
 - Avfuel will cover the cost to brand, re-brand or replace any weathered fuel supplier branding at the Airport. Additionally, we will provide other point-of-purchase branding material that is updated from time to time.

1.4.11 Administrative Support

- i. Provide administrative support relative to supplier/Livingston County Spencer J. Hardy Airport relationship.
 - Avfuel excels at providing administrative support. Whether it is a special report or digging up an old invoice or attending an airport board meeting, we try to meet every need.

1.4.12 Branded Uniform Program

- i. Have availability of a branded uniform program.
 - Avfuel allows our branded dealers to choose uniforms that reflect their personal tastes. We can provide our logo in digital format to a uniform company at no cost. Uniforms that include the Avfuel logo are eligible for reimbursement through the Co-Op Advertising Program (see section 1.4.7).

1.4.13 Technical Expertise

- i. Supplier must provide technical expertise and have available proprietary laboratory support.
 - Avfuel's in-house Quality Assurance team is based in Ann Arbor and has a

wealth of experience. We regularly utilize labs across the country for testing and diagnostic purposes.

1.4.14 Supplier Restrictions

- Supplier may not impose retail/wholesale credit card related discount/rebate program that requires Livingston County Spencer J. Hardy Airport's participation or funding.
- ii. Supplier may not impose retail/wholesale purchase programs requiring Livingston County Spencer J. Hardy Airport participation or funding relating to customer volume discounts.
 - ⋈ (i.&ii.) Avfuel acknowledges the above supplier restrictions.

1.5 Service Capabilities

1.5.1 Communication Plan/Contract Management

Proposers shall identify their company standards of communication as they relate to contract performance, issue management, and change management. An issue is an identified event that, if not addressed, may affect schedule, scope, service, delivery, quality, or budget. A change is identified as a change in corporate leadership, structure, merger or acquisition.

A change, as defined above, is extremely unlikely at Avfuel, as we have enjoyed the same private ownership structure with the same owner for nearly40 years. Should any such change occur, or should Avfuel acquire another company that might impact our customer base, ample notice will be provided.

1.5.2 Primary Account Representative

1.6 Order/Delivery Reporting/Customer Service

1. Ordering Process Capabilities

Proposers shall identify their ordering/customer service capabilities. This includes having the capacity to receive orders electronically, by phone, facsimile, and by written order.

2. Customer Service

It is preferred that the Vendor have an accessible customer service department with an individual specifically assigned to Livingston County. Customer inquiries should be responded to within 24 hours or one (1) business day unless it is an emergency issue. Describe your company's Customer Service Department (hours of operation, number and location of service centers, response times, et. al.).

Avfuel purposely does not have a customer service department because we all work in Customer Service. Our office switchboard is staffed Monday – Friday, 8:00am – 6:00pm and can be accessed at 800-521-4106. Additionally, Avfuel.com and TheAvfuelHub.com have both been built to provide quick access to commonly-requested items (invoices, reports, price changes, etc.). If help is needed outside of these two options, most departments have emergency coverage that can be accessed through the 800 number. Finally, the Primary contact (see Section 1.5.2) can always be contacted after-hours as needed.

1.7 Pricing Schedule

Respondents shall provide pricing on the pricing sheet (Attachment A). Transportation and operational cost increases/decreases from the primary supply points will be passed through with documentation during the term of the contract.

Livingston County Spencer J. Hardy Airport desires to receive the best possible pricing and in order to facilitate the comparison of proposals, it is necessary that all proposals completely explain their method of pricing and how it is tied to available references (i.e. OPIS, Cost of Crude, Gulf Coast Platts, market place, et. al.). Provide an explanation of method of determining fuel price, timing of price changes, and method of conveying price changes to Livingston County Spencer J. Hardy Airport.

Free On Board (F.O.B) Delivered/Destination (Required)

Prices shall be quoted "F.O.B. Delivered/Destination" to each Customer with transportation charges prepaid on all orders of one (1) or more.

1. Bid Pricing

Bid pricing must reflect Net 30 payment terms.

Avfuel's prices reflect 30-day payment terms.

2. Quantity Term

Vendor agrees to supply the complete quantity and products that each customer requires.

Acknowledged. See section 1.3 or more information.

3. Tax Excluded from Price

See Section 4.5.

Base prices listed in Appendix A include delivery fees but no taxes. Taxes are itemized for each product in the table below.

4. Discounts

The Proposer may provide percentage discount based on order quantities. Additional discounts may be included and should be explained. Additional discounts may include Quick Payment Discounts, Volume Discounts, and Rebates. Discount amounts are to be completed in Attachment A.

5. Special Incentives

Livingston County is interested in any other special programs and alternative recommendations that vendors may have.

See Section 1.4.4 for a \$2,000 per year credit (\$10,000 total) to be applied to refueling equipment maintenance expenses. Additional incentives are to be found in refueler truck leasing sections.

Section 2.0: Bidder Information and Acceptance

1. The undersigned declares that the Bid Documents, including, without limitation, any RFP Addenda, and Exhibits have been read.

The undersigned is authorized, offers, and agrees to furnish the articles and/or services specified in accordance with the Specifications, Terms & Conditions of the Bid Documents of RFP-LC-23-10 - Aviation Fuel Supplier for the Livingston County Spencer J. Hardy Airport.

- 2. The undersigned has reviewed the Bid Documents and fully understands the requirements in this Bid and that each Bidder who is awarded a contract shall be, in fact, a Prime Contractor, not a subcontractor, and agrees that its Bid, if accepted by Livingston County, will be the basis for the Bidder to enter into a contract with Livingston County in accordance with the intent of the Bid Documents.
- 3. The undersigned acknowledges receipt and acceptance of all addenda.
- 4. The undersigned agrees to the terms, conditions, certifications, and requirements listed in Section 2.
- 5. The undersigned acknowledges that Bidder will be in good standing in the State of Michigan, with all the necessary licenses, permits, certifications, approvals, and authorizations necessary to perform all obligations in connection with this RFP and associated Bid Documents.
- 6. It is the responsibility of each bidder to be familiar with all of the specifications, terms and conditions and, if applicable, the site condition. PRICE INDEX

Livingston County Spencer J. Hardy Airport desires to receive the best possible pricing and in order to facilitate the comparison of proposals, it is necessary that all proposals completely explain their method of pricing and how it is tied to available references (i.e. OPIS, Cost of Crude, Gulf Coast Platts, market place, et. al.). Provide an explanation of method of determining fuel price, timing of price changes, and method of conveying price changes to Livingston County Spencer J. Hardy Airport.

RESPONSE:

Avfuel Corporation would like to continue to offer the County the opportunity to have its jet fuel pricing tied to a published market index, very similar to the manner in which airlines buy jet fuel. By tying the price to a market index, the County can be assured it is getting the best possible price without concern that its vendor is overcharging. Pricing tied to a market index will move up and down as the market moves, assuring fair pricing throughout the contract term, and not just at renewal time.

The index Avfuel will use for the County is the most commonly used market index for the tracking of jet fuel prices in the aviation industry: US Gulf Coast Jet. The index is tracked and reported by Platts (www.platts.com), which is a leading global provider of energy information.

Avfuel's market index price offer to the County will be defined and calculated as follows: The delivered price of Jet-A will be calculated as the weekly mean average of Platts U.S. Gulf Coast Jet, plus a differential (including current freight charges) of \$0.1665 per gallon. This represents a \$0.0210 per-gallon decrease to the Airport's current pricing formula. The Platt's average price will be calculated each Monday (or Tuesday when Monday is a holiday) for the previous week (Monday-Friday, published trading days only) and will be effective for the following Tuesday through Monday period. Price excludes all taxes, fees, into-plane charges and other fees.

There are no market indexes that track aviation gasoline prices. As a result, aviation gasoline is priced weekly on a market basis. Over the long term, the price of 100LL will generally follow the cost of crude oil and also that of premium unleaded gasoline, but over the short term there is less of a correlation. Avfuel's proposed 100LL pricing reflects a decrease of \$.05650 per-gallon compared to the Airport's current pricing.

Attachment B - Avfuel Training System (ATS) Overview

Avfuel offers Livingston County Airport access to the online Avfuel Training System (ATS). Avfuel will provide the Airport with a free subscription to the ATS, which includes FAA-Approved Line Service Fuel Safety Training and Supervisory Fuel Safety Training to satisfy 14 CFR 139.321 (approximately \$3,200 savings over the normal cost, and thousands less than the Safety First program by NATA). Upon completion, employees receive a Line Service Fuel Safety Training Certification or Supervisory Certification equivalent to NATA.
