Resolution to Authorize a Third Quarter Budget Amendment to the Fiscal-Year 2023 Budget – Fiscal Services

- **WHEREAS,** the proposed amendment ensures compliance with the Uniform Budgeting and Accounting Act, as amended; and
- **WHEREAS,** the proposed amendment recognizes actual expenditure activity for the third quarter of 2023 and includes:
 - Increase in Vision Tour Contingency to estimate for Q4 DAV and PPLEV
 - Increases in various departments for FICA for the MERS DC conversion incentive payments authorized in resolution 2022-12-197
 - Increase in various departments for utility expense for the remainder of the year
 - Net-zero transfer within Courts for IT Chargebacks
 - Net-zero transfer within Planning for carpool rental costs
 - Increase in Drain Commissioner for plan review costs, offset by increased revenue
 - Increase in Sheriff for Axon Standards, professional development, and special event overtime. Increase in Animal Control for MAACO Fall Conference. Increase in Jail for overtime wages, operating supplies, and contract services. These increases in expenses are offset by additional revenue
 - Net-zero transfer within GF Facility Services for park facility repair and maintenance
 - Net-zero transfers in 911 and 911 Enhanced for software, video wall, tower and equipment encryption
 - Increase in EMS for Trinity Health grant purchases, holiday and temporary wages, pending arbitration and fleet maintenance, all offset by increased revenue
 - Net-zero adjustments in Carpool for collision repair and replacement vehicle purchases
 - Increase in Airport for higher fuel costs, office supplies, part-time employee costs, offset by increased revenue
 - Increase in LETS for vehicle repair and maintenance, offset by increased revenue
 - Increase in LETS for repayment of prior year Local Bus Operating funds
 - Increase in FOC and Carpool to reflect actual expense for new vehicle equipment installation
 - Net-zero transfer in Public Defender for IT Chargebacks due to increase in personnel
 - Increase in Landfill for North System Blower Project
 - Net-zero transfer in Facility Services for tools and equipment, architect design assistance, and additional building repairs
 - Increase in Septage Receiving Station for operating supplies, contract services, and utilities to align to the Board of Public Works Budget Plan. These increases are offset by net-zero transfers and an increase in revenue
 - Net increase in Septage Receiving station (\$300) to correct an error from the Q1 Budget Amendment Request,
 - Net-zero transfer within IT for temporary wages, overtime wages, office supplies, bank fees, departmental phone costs, in state travel, out of state travel, utility expenses, and auction commission fees

WHEREAS, the proposed amendment includes an increase in General Fund revenue in the amount of \$204,696 for MMRMA net asset distribution payment, jail inmate transports, and Iosco patrolling contract.
