## **Resolution To Authorize A Fourth Quarter Budget Amendment To The Fiscal-Year 2023 Budget – Fiscal Services**

- **WHEREAS,** the proposed amendment ensures compliance with the Uniform Budgeting and Accounting Act, as amended; and
- **WHEREAS,** the proposed amendment recognizes actual expenditure activity for the fourth quarter of 2023 and includes:
  - Increase to various departments for additional costs associated with the 2023 wage study appeals reclassification of positions
  - Increase in Drain Commissioner salary and fringes from increased callouts for the Livingston Regional Wastewater System; offset by additional revenue
  - Decrease in Drain Commissioner for contract services for private drain issues
  - Increase in GF appropriation to Landfill due to remaining costs associated with the methane collection system project
  - Increase in Community Action Plans for Substance Abuse Disorder Treatment & programing
  - Increase in Sheriff for timekeeping software and miscellaneous supplies; partially offset by increased revenue
  - o Increase in Animal Control for chip readers; offset by additional revenue
  - Increase in Jail for retirement payouts, over-time wages, new supplies contract, and other supply expenses; partially offset by additional revenue
  - o Increase in Attorney / Counsel for December and outstanding invoices
  - Decrease in General Fund Secondary Road Patrol transfer out due to an increase in grant funds
  - Net zero transfer in Medical Examiner for increase in workers comp costs
  - Increase in EMS for temporary wages, scheduled overtime, and bank charges; offset by additional revenue
  - Net zero transfers in the Health Department for membership renewals, token reimbursement for the Prescription for Health Program, and remodel consultation.
  - Net zero transfer in Carpool for the purchase of a decommissioned Explorer for Airport
  - Net zero transfer in Carpool for a caravan transmission replacement for Veterans
  - Increase in Carpool and EMS Carpool line to adjust to actuals
  - Increase in CDBG program transfer out for defederalized program income to be transferred to GF
  - Net zero transfer in Sheriff State Grants for custom signal lasers; offset by additional revenue
  - Increase in 911 Training for various SNC training courses, offset by a decrease in 911 Enhanced
- WHEREAS, the proposed amendment includes an increase in GF General Revenue in the amount of \$2,562,000 for revised taxable value estimates, Community Stabilization Share, State Revenue Share, higher than expected interest rates, interest earned on ARPA funds, and Alcohol and Convention Tax; and
- WHEREAS, the proposed amendment includes an increase in General Fund revenue in the amount of \$130,000 in Register of Deeds for Transfer Tax; and

**WHEREAS,** the proposed amendment includes an increase in General Fund revenue in the amount of \$27,475 in Elections for reimbursements, program income, and campaign finance fees.

**THEREFORE, BE IT RESOLVED** that the Board of Commissioners authorizes the following budget amendment to the Fiscal-Year 2023 Budget as reflected below:
