#### 6.c Potential Topics

Authority, requirements, transparency regarding quarantine of healthy students (not allowed in school) in response to "exposure" of an infectious pathogen.

Review scientific literature discussing negative health effects of mitigations related to attempting to control the spread of infectious pathogens (e.g., masking, vaccines, etc.). Possibly provide information on county website or as a physical document upon receiving vaccines at the Livingston County Health Department (LCHD).

Responsibility of the LCHD in notifying the public of chemical applications (e.g., pesticide application to schoolgrounds, etc.).

Engineering controls to reduce the accumulation of pathogens in the indoor environment, especially in vulnerable or concerning populations (e.g., schools, nursing homes, etc.). Review scientific literature and discuss role of LCHD involvement in recommendations.

Members of the HAC may email the Chair with topics that are not included in these minutes. Topics will be discussed during the next HAC meeting to discuss priority, relevance, etc.
