Resolution Authorizing an Agreement with Indian Trails, Inc. DBA Michigan Flyer, LLC to Provide Airport Transportation Services – LETS

- WHEREAS, shuttle bus service between Livingston County and Detroit Metro Airport (DTW) was identified as a top priority for County residents who participated in public engagement efforts during the 2019 Livingston County Transit Master Plan study; and
 WHEREAS, LETS Transportation does not possess the scale or experience to provide this service directly but can partner with a third-party operator to provide the service under contract; and
- WHEREAS, the Board of Commissioners authorized a five-year agreement with private motorcoach operator Indian Trails, Inc. in October 2019, which operates airport shuttle service from Brighton to DTW through its subsidiary, Michigan Flyer, LLC; and
- **WHEREAS,** during its first five years of operation the shuttle service has become an asset to the community and has steadily gained ridership, and LETS would like to continue offering the service; and
- **WHEREAS,** in accordance with the County's Procurement Policy, a formal bid process was performed in collaboration with Fiscal Services and CoPro+ to request proposals for Airport Transportation Services per the attached bid synopsis; and
- **WHEREAS,** the evaluation committee recommends a contract award to Indian Trails, Inc. DBA Michigan Flyer, LLC, the incumbent vendor, using the cost structure in Attachment A Pricing Proposal; and
- WHEREAS, the agreement term will be five (5) years beginning October 1, 2024 and ending September 30, 2029; and
- **WHEREAS,** the contract is eligible to receive grant funding from the State Local Bus Operating program, which will fund approximately 35% of the gross operating cost, with passenger fares and a contribution from Indian Trails, Inc. DBA Michigan Flyer, LLC funding the remaining cost; and
- **WHEREAS,** the County's financial contribution is estimated at \$767,795 annually but will not exceed the amount of grant funds received from the State, and no local funds will be required; and
- WHEREAS, the Contract Services expense is included in the LETS 2024 budget.
- **THEREFORE, BE IT RESOLVED** that the Livingston County Board of Commissioners hereby authorizes an agreement with Indian Trails, Inc. DBA Michigan Flyer, LLC of Okemos, MI to provide airport transportation services for a term of five (5) years beginning October 1, 2024 and ending September 30, 2029, with a County contribution estimated at \$767,795 annually but not to exceed the amount of grant funds received from the State.

BE IT FURTHER RESOLVED that the Chair of the Livingston County Board of Commissioners is authorized to sign all forms, assurances, contracts/agreements, renewals and future amendments for monetary and contract language adjustments related to the above upon review and/or preparation of Mark Koerner, LETS Transit Attorney.
